

## RECOMMENDATIONS

The following recommendations, born out of the insightful discussions at the Round Table Conference, aim to contribute to a more inclusive and equitable electoral landscape, fostering the active participation of women in the democratic process:



- 1. Enforcement of Quotas: The participants strongly recommended that the Election Commission of Pakistan proactively identify political parties that have failed to comply with the mandated 5 percent quota for women candidates, as stipulated in the Elections Act 2013 (amended 23). The Election Commission should compel non-compliant political parties to rectify this matter in accordance with the existing Act.
- 2. Strengthening Institutions: There is a need to bolster human machinery by enhancing the capacity and capabilities of institutions. This initiative is not only crucial for the upcoming general election in 2024 but also for subsequent elections. Strengthening institutions will contribute to a more robust and inclusive electoral process.





- 3. Security for Women Candidates and Voters: ECP should ensure full proof security to all women contestants in the upcoming elections. The Election Commission is urged to take proactive measures, media should provide equal coverage to women candidates. This step is crucial for fostering a safe and inclusive electoral environment.
- 4. Timely Legislation Follow-Up: Emphasis on the urgency of following up on pending pro-women legislation immediately after the new cabinet is sworn in. Ensuring proper representation of women in the cabinet is vital for advancing gender equality in decision-making processes.
- 5. Utilizing Technology for Inclusion: The potential of technology in facilitating women candidates, voters, and supporters. The Election Commission is urged to ensure the inclusion of women facing accessibility and mobility challenges in the electoral process. Political parties are encouraged to base their manifestos on women-led political processes to ensure gender political equality.
